

**ACKNOWLEDGEMENT OF RESPONSIBILITY**

**IN CONSIDERATION OF THE UNDERSIGNED** being permitted to shoot, compete, observe, or participate in any way in activities on the premises of Prairie Woods Environmental Learning Center ("PWELC") shooting range ("Premises"), **EACH OF THE UNDERSIGNED** for himself/herself, his/her personal representatives, heirs, and next of kin:

1. **ACKKNOWLEDGE, AGREE THAT THEY ASSUME THE RISK** in the course in firearms and taking part (including observing) in activities on the Premises, which include, (not limited to), instruction in use of firearms, discharge of firearms, and firing of live ammunition by both instructors and pupils ("Event");
2. **MINORS (under age of 18) SPECIFICALLY ACKNOWLEDGE** that he/she will look solely to their parent or guardian (and/or the person whose name is countersigned here) in the event of any claim for damages, losses or bodily harm.
3. **PARENT/GUARDIANS (including the person whose name is countersigned here) SPECIFICALLY ACKNOWLEDGE** that they will undertake any duty of care reasonably expected by the minor and agree to indemnify, save, and hold harmless PWELC its instructors, officers, agents, employees from any loss, liability, damage, or cost PWELC, its instructors, officers, agents and employees, may incur arising out of or related to their own (or the minor's) presence at and/or participation in the course of instruction, the discharge of firearms on or any related use of or Event on the Premises;
4. **RELEASE, WAIVE, DISCHARGES AND COVENANTS NOT TO SUE** PWELC, its instructors, officers, agents and employees for any damages, losses or bodily harm, or make any claim or demands therefore on account of injury to the person or property or on account of death of any participation in the course of instruction, the discharge of firearms on or arising out of any related use of or Event on the Premises;
5. **ASSUME FULL RESPONSIBILITY FOR ANY RISK** of injury to the person or property including death of any participation in the course of instruction, the discharge of firearms on or arising out of any related use of or Event on the Premises;
6. **AGREE TO ABIDE BY ALL SHOOTING RANGE RULES AND PROCEDURES** and any other rules and procedures stated by the instructor while at the Event;
7. **AGREE TO REPORT ANY INJURY OR UNEXPECTED HAPPENING WITNESSED OR KNOWN WITHIN 72 HOURS TO PWELC OR THE SUPERVISOR;**
8. **CONSENT TO** and understand that instructors may find to necessary to help students in correct shooting posture by appropriate hands-on/touching;
